General Fund Collections Above Estimate for November

eneral Fund revenue collections for the month ended November 2014 totaled \$1.73 billion, which was \$5.6 million, or 0.3%, above estimate for the month. Fiscal year-to-date collections total \$10.6 billion, which is \$109 million, or 1.0%, above estimate for the year. Compared with 2013 revenue collections, November 2014 collections were \$33.9 million, or 2.0%, above last year.

Fiscal year-to-date 2014-15 total General Fund revenue collections are \$694.6 million, or 7.0% ahead of last year. This amount includes one-time transfers to the General Fund from special funds such as \$95 million from the Small Business First. Fund and \$85 million from the Machinery and Equipment Loan Fund. A comparison of General Fund tax revenues, excluding these one-time items, shows that tax revenues have increased by \$458.4 million, or 4.7%, over last vear through November.

November's corporation tax collections were above estimate by \$3.0 million, or 5.4%. November is typically one of the lowest months of the fiscal year with regard to corporation tax collection amounts. Corporation tax collections are \$86.1 million, or 11.1%, above estimate for the year.

Sales and use tax (SUT) collections were above estimate for the month by \$5.0 million, or 0.7%. Non-motor SUT was above estimate by \$10.5 million, or 1.6%,


for the month, but SUT on motor vehicles missed the estimate by \$5.4 million, or 6.0%. Sales and use tax collection amounts this November were \$26.3 million, or 3.6%, ahead of last year for the same month. Sales and use tax collections are \$190.1 million, or 5.0%, ahead of last year for the fiscal year-to-date. SUT is \$49.4 million, or 1.3%, more than estimate for the year.

Personal income tax (PIT) collections were ahead of estimate by \$1.3 million, or 0.2%, for the month. Employers' withholding tax was \$866,140 above estimate for the month. Estimated PIT payments were \$247,796 over es-

timate for the month, and annual tax payments were \$152,078 above estimate. PIT collections are \$124.4 million, or 3.1%, ahead of last year's collections through November. However, PIT is \$10.8 million, or 0.3%, below estimate for the year.

Realty transfer tax (RTT) collections failed to meet the estimate by \$9.6 million, or 27.7%, for the month. RTT collections are \$27.2 million, or 13.4% short of estimate for the year, and they are only 1.3% ahead of last year at this time. Inheritance tax collections were above estimate by \$10.1 million, or 18.2%, for the

month. Cigarette tax collections were \$6.8 million, or 7.6%, below estimate. Liquor tax collections totaling \$30.1 million were \$1.4 million below estimate for the month.

Non-tax revenue was \$6.6 million below estimate for the month of November, and it is \$76.3 million, or 19.6%, below estimate for the year. It bears repeating that the \$80 million Liquor Store Profit transfer set to occur in September was not made, and so non-tax revenue, and the General Fund, remains skewed downward by \$80 million.

Motor License Fund collections

were \$10.5 million above estimate for the month of November. The Motor License Fund is \$13.8 million, or 1.4%, ahead of estimate for the year.

The year-to-date General Fund revenue surplus is welcome news, however, it does not mean that the Commonwealth is not facing serious fiscal challenges in the remainder of the fiscal year and in the budget year. At the mid-year budget briefing, Secretary Zogby indicated that supplemental appropriations of nearly \$52 million will be necessary for the Department of Corrections for the current fis-

cal year. He also noted that certain revenues totaling about \$234 million assumed in the official revenue estimate may not come to fruition. These include cigarette taxes (-\$14 million), casino license fees (-\$125 million) and non-impact drilling revenue (-\$95 million). In addition, the projected General Fund cost-to-carry for mandated programs was estimated at approximately \$1.8 billion.

It is clear that the FY 2015-16 budget will be extremely challenging and the Commonwealth faces the difficult task of closing a significant budget gap.

2015 Budget Hearings




Official Revenue Estimate Monthly Distribution


When ranking estimated monthly revenue collections from largest to smallest, November ranks eleventh at \$1.729 billion or 5.73% of total General Fund estimated revenues. December is the fifth largest collection month at \$2.550 billion or 8.45% of estimated annual General Fund revenues.


2014 Mid-year Budget Briefing
