## **General Fund Collections Dip in January**

eneral Fund revenue collections for the month ended January 2014 totaled \$2.36 billion. which was \$43.5 million. or 1.8%, below estimate. Fiscal year-to-date collections total \$14.6 billion, which is \$40.9 million, or 0.3%, below estimate. January is a "quarterly estimated tax payment" month for personal income taxes and is typically the month having the largest share of sales and use tax collections for the entire fiscal year.

Corporation tax collections were above estimate by \$30 million, or 29.4%, for the month. January is not a particularly important month for corporation taxes. Corporation tax collections are \$87.9 million, or 6.5%, ahead of estimate for the year-to-date.


Sales and use tax collections were below estimate by \$6.9 million, or 0.8%, for the month. January's general sales and use tax collections are the highest of the fiscal year because the taxes collected in December, during the peak of the holiday shopping season, are remitted in January. General SUT was \$1.7 million, or 0.2%, below estimate. Sales and use tax on motor vehicles was \$5.3 million, or 5.7%, short of esti-

mate for the month. Sales and use tax collections are \$22.4 million, or 0.4%, below estimate for the fiscal year-to-date. Overall, sales and use tax revenues are 2.4% ahead of last year at this time. The Official Estimate anticipates year-over-year sales and use tax growth of 3.8%.

Personal income tax collections were below estimate by \$71.3 million, or 5.6%, for the month. PIT from employers' withholding missed the estimate by \$37.1 million for the

month. Quarterly estimated PIT collections were \$32.6 million short of estimate for January. The quarterly payments due in January represent the final installments for the 2013 tax year. Payments on annual tax returns were \$1.6 million below estimate for the month. PIT collections are \$100.5 million, or 1.6%, below estimate for the year, and they are running only 1.6% ahead of last year at this time. The Official Estimate calls for 3.1% annual growth over last year.

## The Monthly Report

Realty transfer tax collections missed the estimate by \$2.1 million over for the month. RTT is now \$9 million below estimate for the year. Inheritance tax collections were \$3.1 million below estimate for the month, and they are \$8.9 million below estimate for the year.

Cigarette tax collections were \$4 million below estimate for the month and are \$9.2 million short of estimate for the year. Liquor tax collections just beat the estimate at \$431,003 over for January. Table games tax revenue was \$644,487 short of estimate for the month.

Motor License Fund collections were \$1.3 million below estimate for the month of January. The Motor License Fund is \$11.1 million below estimate for the year.


## **Senate Appropriations Budget Hearings Set to Begin**






