

#### **General Fund Revenues Outpace the Estimate in October**

eneral Fund revenue collections for the month ended October 2013 totaled \$2.1 billion, which was \$29 million, or 1.4%, above estimate for the month. Fiscal year-todate collections total \$8.2 billion. which is \$41.8 million, or .5, above estimate for the year. Fiscal year-to-date total General Fund revenue collections are \$87.9 million, or 1.1%, ahead of last year. As of October 2013, the fiscal year revenue surplus stands at \$41.8 million compared to a fiscal year-to-date revenue surplus of \$82.2 million last year through October.


October's corporation tax collections were above estimate by \$20.2 million. During October, some corporations that have a six-month filing extension from April pay their CNI and CSFT annual payments late. Even though the filing of returns can be extended, tax payments for calendar year filers were due in April 2013, regardless of extension. The relatively strong corporate net income tax annual payments received this month account for most of the monthly overage. Corporation taxes are \$10.2 million over estimate for the vear-to-date.

Sales and use tax collections were above estimate for the month by \$5.3 million. Nonmotor SUT was below estimate by \$800,000 for the month, but SUT on motor vehicles was above estimate by \$6.2 million. Year-to-date sales tax collections are \$25.9 million, or .8%, more than anticipated. Consumption taxes (i.e. SUT, cigarette, malt beverage, and liquor) are \$3.9 million below estimate for the year-to-date.

Personal income tax collections were above estimate by \$2.4 million. Employers' withholding tax was \$2.3 million short of estimate for the month, but payments on annual tax returns exceeded estimate by \$8.2 million. Estimated PIT payments were \$3.5 million short of estimate for the month. As with corporation taxes, individuals that have a six-month filing extension sometimes make annual tax payments in October even though the taxes were due in April. Personal income taxes exceed the estimate by \$5.3 million for the year-to-date.

Realty transfer tax was below estimate by \$3.6 million for the month. Inheritance tax collections were \$100,000 below estimate for the month. Cigarette


tax collections missed the estimate by \$1.7 million, liquor tax collections were \$100,000 below the estimate, and table games tax collections were \$300,000 below estimate for the month. Non-tax revenue collections exceeded the estimate by \$6.6 million.


Motor License Fund collections were \$2 million above estimate for the month of October. The Motor License Fund is \$14.5 million below estimate for the year.


### PA Race Horse Development Fund Collections On Track To Exceed \$250 Million

The PA Race Horse Development Fund was developed to support and advance the Commonwealth's horse racing industry. Revenue is derived from a daily assessment from each licensed gaming facility and is capped at 12% of gross terminal revenues. Proceeds are distributed to licensees conducting live horse racing. Track owners deposit 80% of the proceeds into a purse account. The remaining revenues are distributed to standardbred and thoroughbred breeding funds and various horsemen's organizations.

Revenues through October 31st averaged approximately \$5 million per week and total more than \$85.5 million for the year. Total fund revenues for the fiscal year are expected to exceed \$250 million.
