Monthly Report October 2021

First Quarter 2021-22 Fiscal Year Revenues

General Fund revenue collections for the month of September exceeded the estimate by \$495.9 million, or 14.1%. General Fund tax revenues were \$478.4 million, or 13.7%, higher than the monthly estimate, and non-tax revenue exceeded the estimate by \$17.5 million. General Fund revenue collections for the first quarter of the fiscal year are \$628.3 million, or 7.3%, ahead of estimate.

Total corporation tax revenues outperformed the monthly estimate by \$233.7 million, or 35.2%. September is an important quarterly estimated payment month, and quarterly estimated corporate net income tax (CNIT) payments were above the estimate by \$183.8 million, or 35.4%. Annual CNIT payments also were ahead of estimate by \$34.5 million, or 26.8%. Quarterly estimated CNIT payments are due again in December, and hopefully September's overperformance will be repeated three months from now.

Sales and use tax (SUT) collections beat the estimate by \$93 million, or 9%. September 2021 SUT collections were 13.2% higher than September 2020, and SUT collections are 5.9% above last year through the first quarter of the fiscal year. General sales and use tax collections (i.e., non-motor vehicle SUT) is 8.5% higher than last year, but SUT collected on sales of motor vehicles is 8.7% below last year's revenues.

Quarterly estimated personal income tax (PIT) collections due in September exceeded the estimate by \$104 million, or 25.5%; however, PIT withholding was below estimate by \$10.6 million, or 1.1%. Total PIT collections were 15.2% higher than last year for the month of September, but they are 23.2% lower than last year through the first quarter of the fiscal year because of tax filing extensions enacted for FY 2019-20 that shifted significant PIT payments into FY 2020-21. PIT withheld from paychecks was not affected by last year's tax deadline changes or revenue shift, so this category of PIT revenue can be compared to last year in a consistent manner. FY 2021-22 PIT withholding revenues are 5.1% higher than PIT withholding collections in FY 2020-21 through the first quarter of the fiscal year.



First Quarter 2021-22 Fiscal Year Revenues Continued.....

September 2021 General Fund Revenue vs. Monthly Estimate:


- General Fund revenue collections of \$4 billion were above the monthly estimate by \$495.9 million, or 14.1%.
- General Fund tax revenues were overestimate by \$478.4 million, or 13.7%.
- Corporation taxes were \$233.7 million, or 35.2%, above estimate.
- Sales and use tax collections beat the estimate by \$93 million, or 9%, for the month.
- Personal income tax collections were above estimate by \$97.8 million, or 6.8%.
- Non-tax revenues exceeded the estimate by \$17.5 million. It appears that a \$10 million sports wagering license fee paid in September caused much of the overage.



- Total General Fund revenues are \$628.3 million, or 7.3%, higher than the Official Revenue Estimate through the month of September.
- General Fund tax revenue is \$610 million, or 7.1%, above estimate.
- Corporation taxes are \$257.4 million, or 27.3%, higher than the estimate.
- Sales and use taxes are \$142.3 million, or 4.3%, above estimate.
 - o General SUT collections are \$141.7 million, or 4.9%, above estimate.
 - o SUT collections on motor vehicle sales are \$554,000, or 0.1%, higher than the estimate.
- Personal income tax collections are ahead of estimate by \$164.9 million, or 5%.
 - o Withheld PIT is \$44.6 million, or 1.6%, above estimate.
 - o Non-withheld PIT (annual & estimated payments) is \$120.4 million, or 20.2%, overestimate.
- Realty transfer tax revenues are \$16.3 million, or 9.8%, above estimate.
- Inheritance tax collections are \$12.8 million, or 3.6%, above estimate thus far for the fiscal year.
- Non-tax revenues are \$18.3 million, or 27.2%, above estimate.


Fiscal Year 2021-22 vs. Fiscal Year 2020-21:

- Total General Fund revenues through September are \$636.6
 million lower than last year at this time because of personal
 income and corporation tax filing extensions that shifted
 payments into July and August of 2020.
- Last year's tax filing extensions resulted in \$1.8 billion being shifted from FY 2019-20 into the first two months of the 2020-21 fiscal year.
- This one-time anomaly skews any comparison between FY 2020-21 and FY 2021-22 tax collections, especially corporation taxes, sales and use taxes and personal income taxes.



Motor License Fund:

- Motor License Fund revenues are above estimate by \$22.5 million, or 3.2%, through September.
- Motor License Fund revenues are \$40.2 million, or 5.2%, less than last fiscal year at this time.
- Motor License Fund collections during the spring of 2020 were disrupted, which resulted in higher-than-normal revenues being received later in the year.
